hug squeeze. Each month: the Center must raise and pay appreximately \$500 -- te cover rental, cost of utilities (electricity and phone); and supplies. Faced by relentless inflation laced with recession, high unemployment -- in short, tight money -- the outlook for the Center in the coming

menths is bleak, particularly July and August.
Pledges and contributions to the Center have fallen off. This is understandable in view of the fact that most paychecks still trail the rising cost of living.

In admitting to a mood of uncertainty and concern about its future, the Center, however, is confident that it can cope with these financial problems.

The staff feels that it can count on the generosity and concern of

friends to keep the Center fiscally afleat.

It may be werth repeating at this point that, no matter the amount, 100 per cent of every pledge and every contribution goes toward the operation and maintenance of the Center. Nothing is taken out for salaries. Every staff member is a volunteer and receives no renumerations for services rendered. In addition, every denation is income tax deductible.

A well-known fund raiser recently observed: "Hard times den't make
