GUEST FROM JAPAN



Dear Mr. Sasaki:

During the closing months of 1975 two severe blood shortages caused the cancellation of all nonvital surgery for a period of time. As we are an island community, completely dependent upon ourselves to provide the necessary 2500 pints each month, something had to be done to prevent future occurrences.

To solve the problem the following changes in our program were made January 1st:

- 1. The reinstatement of a \$15 blood replacement fee.
- 2. Members who enroll in the Blood Service Plan for cash are covered for the processing fee of \$25 only and must replace each unit used or pay a fee of \$15 per unit. Those who enroll with a blood donation are covered for both the processing fee and the blood replacement fee.
- 3. The reinstatement of organizational reserves for clubs and churches where their members who cannot donate, but pay for coverage, can go for replacement credits. These donations would be good for two years and would cancel on a one for one basis the \$15 replacement fee. The reserve should have a chairman through whom we would receive authorization to cover the members in need. It goes without saying that the reserve is only good for the number of units in it. The chairman is notified with a printout each month that there is activity in or out of the reserve.
- The development of the new "Lifesavers Club" for company group participation is to be publicly launched May 19, 1976. (See enclosed brochure.)

If you are interested in forming a reserve, please let me know and I'll give you a number. (We now have our records in a computer.) If there is any way I can be of help, please don't hesitate to call on me.

VETERANS ADMINISTRATION

LIFE INSURANCE

Veterans holding National Service Life Insurance (NSLI) policies are encouraged by the Veterans Administration to give consideration to converting the five-year premium term insurance to a permanent-plan policy.

The NSLI program was started in 1940 to serve the insurance needs of World War II servicemen, a VA spokesman explained. More than 22 million policies were issued before the program was closed in 1951. There were 16 million policies in force with a face value in excess of \$121 billion during the peak enrollment in 1944.

At the end of fiscal year 1975, there were four million policies still in force with a face value of \$26 billion. Of these, 2.5 million have been converted to permanent plans. The VA counselors are directing their attention to the remaining 1.5 million policyholders.

Term insurance premiums increase sharply at each renewal after age 50, often imposing a hardship on the policyholder. While premium rates for permanent plans are higher than for term policies issued at the same ages, they remain constant throughout the life of the policy.

The VA stressed that the decision to convert from term to a permanent insurance plan must be based on the veteran's present and future needs for insurance, its cost and the veteran's ability to pay for the coverage.

The VA offers a number of permanent plans of insurance, all of which offer cash and loan values while avoiding future premium increases. Included are modified life plans, ordinary life, limited payment life and endowments.

Veterans now receiving insurance dividends will continue to receive them after conversion, the amounts depending on the new insurance plan. Policyholders who purchased paid-up additions to their term insurance will be permitted to retain the paid-up additions with the new permanent plan.

Complete information on insurance coverage and counseling on conversion options is available at all VA offices.

QUESTIONS AND ANSWERS

- Q Does the VA make allowances for refresher training in a program for which the veteran was previously qualified through former schooling or experience?
- A Yes. A new program of refresher training for a maximum of six months allows updating former experience or education gained prior to service.
- Q How and to whom may a Presidential Memorial Certificate be issued?
- A Normally a certificate is issued automatically to the veterans's next of kin. Your nearest VA regional office can assist with application procedures.
- Q I wish to review my records maintained by the VA to determine validity of certain documents. Who should I contact?
- A The Privacy Act of 1974 grants indiciduals the right to access and to seek correction or amendment of records pertaining to the veteran or beneficiary. Submit a written request to the VA regional office that maintains your records.
- Q I am a married veterans attending college under the G. I. Bill and am having financial difficulty. Are there any other VA programs that might assist me?
- A There are two possible sources of assistance. A veterans attending on a full-time basis may apply to participate in the VA's work-study program. Full information is available through the VA regional office or the Vet Rep on campus.
- Q Are all veterans eligible for a nonservicedisability pension?
- A No. Only veterans with 90 days or more honorable wartime service who are permanently and totally disabled from reasons not traceable to service are eligible.
- Q How long does a veterans have to use G. I. home loan entitlement?
- A Loan entitlement is no longer subject to an expiration date.

- O I understand the school notifies the VA when a veteram student drops out of G.I. Bill training. Why should the veteran have to duplicate this notification?
- A It is the veteran's responsibility to prevent VA overpayments by notifying the VA upon termination of training. Sometimes the time lag in the school's notification causes an overpayment to the student who must then repay repay the VA.
- Q I have been granted a waiver of premiums on my NSLI policy, five-year level term, because I am permanently and totally disabled. Can I convert this policy to a permanent plan and retain the waiver?
- A Yes, provided conversion is to other than an endowment plan. Waiver of premiums would continue on the new policy. If, however, you become able to maintain substantial employment, the waiver of premiums would be discontinued.
- Q Haven't there been a change in VA regulations which allows a remarried widow to regain pension benefits if the second marriage is dissolved?
- A Since 1971, the remarriage of an eligible widow does not prevent resumption of death benefits to the widow when the subsequent marriage is terminated.
- O As long as the Post Office notifies the VA of my change of address, why do I have to?
- A You are responsible for notifying the VA of any change of address or your cash benefits will be suspended. The Post Office does not notify the VA of address changes. You must notify the VA just as you would friends and relatives.
- Q What are the Vietnam war dates, for purposes of veterans' benefits?
- A Inclusive dates for the Vietnam Era are August 5, 1964 through May 7, 1975.
- O Which of the VA's insurance plans pay dividends?
- A U.S. Government Life Insurance ("K") policies National Service Life Insurance ("V") policies); and Veterans Speical Life Insurance ("RS-W" policies).

- Q May a G.I. loan be paid off before the final payment date?
- A Yes. A VA guaranteed loan may be partially or fully paid at any time. However, part payments may not be less than one monthly payment or \$100, whechever is less.
- Q Who can change the name of the beneficiary of my VA life insurance?
- A Only you can, and you must notify the VA in writing.
- Q I recently read that I may be entitled to an additional nine months of schooling under the G.I. Bill. Is this correct?
- A Yes, if you were originally entitled to 36 months entitlement; were enrolled in a standard undergraduated college or first professional degree program when your entitlement was exhausted; if you have not completed requirements for a baccalaureate or higher degree, and if you need up to nine months to continue your pursuit of a bachelor or first professional degree.
- Q I know that I can claim unusual medical expenses at the end of the year to reduce my income for VA pension purposes. I am on a special diet which included expensive foods and vitamins. Can these items be included in my claim?
- A Yes. Cost of foods, beverages and vitamins, when specially prescribed by a doctor for treatment of illness and in addition to, not as substitute for, regular diet are allowed as medical expenses. A statement from your doctor must accompany your claim.
- Q What is the interest rate on VA guaranteed home loans?
- A The maximum interest rate on G.I. loans varies from time to time pursuant to changes in laws and VA regulations and the economy. However, once a loan is made, the interest rate set forth in a note remains the same for the life of the loan. Presently the interest rate on VA insured loans is 8.75 percent.
- Q My brother is a World War II veteran who can hardly sign his name on his pension check. What should I do?
- A Your brother may use an "X" for signature. Write his name below the "X" and have two persons sign as witnesses.

VETERANS ADMINISTRATION

While the Veterans Administration is the primary Federal agency serving former members of the nation's armed forces, a number of veterans' benefits and services are available from other government sources.

William C. Oshiro, Director of the Veterans Administration's Honolulu Regional Office, listed the following benefits available to qualified veterans and their families:

- FHA Home Mortgage Insurance up to a maximum of \$45,000. A minimum cash investment is required: 10 percent of the dwelling's value between \$25,000 and \$35,000 and 15 percent of the value above \$35,000. The maximum interest rate is 9 percent plus a mortgage insurance premium of 1/2 of 1 percent:
- -- A government guarantee of the premiums and interest due on eligible commercial life insurance policies not exceeding \$10,000 in any individual case for two years after discharge:
- Unlimited commissary and post exchange privileges for honorably discharged veterans with 100 percent service-connected disability, their dependents and unmarried widows:
- Supervised credit and management advice and loans for housing in rural areas or in towns of up to 10,000 population may be obtained from the Agriculture Department's Farmers Home Administration:
- · -- " Preference in Federal Civil Service employment, including points added to passing scores in competitive examinations, waivers of physical requirements, restriction of certain jobs to veterans, preference for retention in case of reductions in force, and similar advantageous procedures for veterans, their unremarried widows and mothers of deceased veterans:
- -- Preference in referral to training programs in private or public schools and for onthe-job training:
- Small Business Administration assistance including loan guarantees and management assistance designed to encourage veterans in owning and operating a variety of small businesses:
- -- Social Security credits toward monthly retirement, disability and survivors benefits are available to qualified veterans and their families.

VA DEPENDENT EDUCATION

More than 365 veterans' dependents are enrolled in college studies or other training in Hawaii, Guam and American Samoa, according to William C. Oshiro, Director of the Veterans Administration's Honolulu Regional Office. The 365 trainees are widows, wives of totally and permanently disabled veterans, and their children who are eligible for Dependents Educational Assistance benefits.

A total of 88,000 dependents are in training annually across the nation. Of the total, 38,000 were dependents of veterans who served during the post-Korean period and the Vietnam Era.

Their checks from the VA generally are \$270 per month for full time training. Included are wives of prisoners of war and the missing in action, some of them attending colleges in Europe, the Middle East, and other foreign areas.


Overseas attendance at institutions of higher learning is permitted by the VA under its dependents educational assistance, although the schools must be approved by the VA Central Office in Washington, D. C.


Last year, 50 children and five women received special restorative training for physical or mental handicaps. This involves speech and voice correction, lipreading, and braille reading and writing. Special vocational training also may be provided.

VA checks average \$260 per month for full time restorative training. In some cases, handicapped children may begin a special vocational or restorative course with VA assistance as early as age 14.

To attend school or take job training with VA help, but their program must be pointed toward a definite educational or vocational goal, Oshiro noted.

Full information and application forms for VA dependents educational assistance are available at any VA office. Complete information also may be obtained from local veterans service organization representatives.



1/2 tsp. salt
1/2 tsp. baking soda
1/2 cup quick oats
1/2 cup nuts

Cream shortening, sugar & egg
Add vanilla
Add flour sifted with salt & soda
Add quick oats and nuts
Roll dough 1" in diameter and freeze
Slice thin and bake in 350 degree in
ungreased pan till brown.

BUTTER COOKIES

1½ cup sugar 1 lb. butter

2 eggs

5 cups flour tsp. salt

1 tsp. baking powder 1 tsp. vanilla

Chill for 1 hour. Roll dough in 1 inch ball Flatten with fork in center criss cross Bake on greased pan at 350 degree.

l cup butter (melted)


2 cups Bisquick




