"Kodomo No Tame Ni..." This phrase is familiar to most of us, I'm sure. Demnis Ogawa used it as a title for one of his popular books on the Japanese-American experience in Hawaii. Kodomo no tame ni, was brought home to me recently when my daughter graduated from the U. of H., thus ending more than twenty years of toil on the part of her parents to see her through school. This obligation of ours, to do everything in our power to give our children an education, is shared by many of us, and for the most part, we've done it gladly ungrudgingly, and without regret. For what else, of lasting value, could we have given our offsprings?

I think it's fair to say that each of us, whether consciously or not, lived and worked --struggled through hard times, for the sake of our children. Upon serious reflection, even the fact of our having volunteered to enlist in the Army was done, not for selfish reasons, but for the sake of a generation of children yet unborn. And now, almost 40 years later, that generation of young men and young women is well on its way to being established, the fulfillment of our fondest dreams.

In increasing numbers, we the dads and moms of these young tyros, are entering a well-earned retirement, somewhat contented with what we see and have around us, including another generation of off-springs, our grandchildren. And this is what brings me to wonder about the future of our club and all that it has stood for as a reminder of our patriotic zeal, "kodomo no tame mi." Will some of our children see for themselves the symbolism of the flaming torch as it represents the ideals, the hopes and the dreams for which their fathers and mothers had toiled long and sacrificed much in trying to provide the things which they never had for themselves, the opportunities that were denied them?

As I recall that first day in combat in Italy, while we were preparing to move up on the line, I mumbled to myself, "This had better be for something good." Thirty-nine years later, I cam justly say, "Yes, for the sake of our children, it sure was."

Hisashi Kubota, 232nd Engrs/Band Chapter's mainland correspondent reports to you from Tennessee:

It brought back memories of a small booklet which was picked up from a dead Japanese soldier and brought to my attention. It was titled, "A Housewife's Premier." It started out to the effect that "let's face it, it is us housewives who run everything both in the home and in the country, however, the trick is to run the show while keeping things under control and let the menfolk think they are running the show and originating the ideas we put into their mouths." It made me wonder whether the wife who pretends not to be able to read Japanese is playing possum or somehow had gotten hold of a translation.

In any event, I found myself back in Honolulu the early part of August, so I dropped in on the clubhouse one morning to say hello to Bob Sasaki and also to inquire when the Engrs. would next meet. The date given was a couple days later, and I managed to remember the date and made it to the clubhouse on the appointed evening I entered on a scene very unlike anything I had ever seen as far as conducting meetings was concerned. What I came across seemed like a cross between the Dai Isshiki and Dai Nishiki of Japanese gatherings. There was a semblance of a meeting taking place at the center of the hall while this business area was fringed by different groups attacking assorted pupus and being complemented by a bar on the fourth side. Needless to say, everyone was busily engaged, and it seemed such an efficient way to conduct a meeting, however, the poor officers did not get too much refreshment during the meeting, but they put dedication above everything else. What impressed me greatly was the number of guys present. I recalled meetings of the past when we had to almost shanghai guys to show up, and this seemingly spontaneous turnout of such large number surely was great. I should have simply said hello and retreated, but the lure of the old days was too great, and I stuck around for a while. I was to regret this in due time.

When I saw him approaching with a smile, I knew I was finished. First the usual greetings, then the buttering up, and then the gentle persuader. Now, it was no high powered pitch he hit me with, but before I knew it, I had agreed to write just one more account for the Bulletin. That Hichi is a sly one.

Now this occurred two years ago. It is the story of my life getting myself into situations from which I wonder how I ever got into such a mess and just how to extricate myself. There was no reunion that year. In fact, it was a time of letdown from the reunion of the previous year. What in the world could I write about sitting in the hills of East Tennessee which could be of interest to the people of Hawaii. A long time ago, I made the statement describing this area to be wonderful in April when the dogwoods are in bloom and in October when the leaves turn color, and back come the statement "but what do you have in between?"

The next thought was to forget it, however, the guilty feeling keeps creeping up all the time. Then there is the upcoming NVR, and I am sure Hichi is not going to forget that I had agreed to do this bit. What can be worse than becoming the target for his barbed comments. Meanwhile the months kept rolling along.

In the meantime, there transpired a major change in my lifestyle. I retired from my job of the last 26 years, and started an altogether different life. After several months of this new life, it suddenly dawned on me that here is something I have in common with many of the guys back in Hawaii and certainly this is an area of interest because most of us eventually will fall into this category.

The idea of retirement apparently is a rather recent development particularly where retirement with some sort of stipend is concerned. Where once the general rule was to die in one's boots while still working and only a lucky few who struck it rich could retire, today almost everyone retires at 65 if not sconer and collects some sort of pension.

The Roosevelt administration concocted the concept of social security. The way it was initially designed, it was a wonderful thing providing insurance for the family of the worker in the event of his death, a disability compensation in the event he became disabled, and finally a pension to tide over his final days once he reached his 62nd or 65th birthday. There was a time in the fifties when the social security funds were accumulating to such a high level that congress could not stand still and began loosening some of the requirements. Then came medicare. So now social security is in trouble and has become a sore point that is haunting the powers that be. On the other hand, the retirees who depend almost entirely on the social security check for subsistence are uneasy not knowing when the boom will be lowered. It does seem that most of the vet-

erans in our category will be assured at least some return, and they will possibly be better off than the younger ones to follow.

Many of the larger companies have pension plans as has the federal government. Most of these plans have some formula which takes into account, age and company service to determine when and with how much one can retire. About ten years or so ago, there was a trend for people who became eligible for company pension even at some rather low level to retire early and either look for another job or just take it easy. I can remember many who just could not wait for that day to come, however, another fly in the ointment appeared. There was the nasty item of inflation.

Twenty-five years ago, one could pick up a magazine and find insurance company ads saying retire in 10 years at \$150 a month. Ten years later the same ad said retire on \$300 a month. If one had gone into such a plan 15 years ago and retired 5 years ago on \$300 a month, his would be a marginal existence at best. This unexpectedly accelerated increase in inflation is causing havoc among the ones who had planned to retire between 50 and 60. Very few can find another job anywhere close to the one he presently holds, and it is only a very few who can make it on just company pension plus something else he has stashed away. So there has been a temporary lull in early retirements, and it will be interesting to see whether the situation will change in the near future.

About 15 years ago an interesting item appeared from the industrial relations department at the plant where I used to work. It turned out that, at that time, the average number of pensions checks collected by a retiree was 17. In other words, the average retiree lived only about a year and half after retirement. This was an appalling statistic. At that time, most of the retirees were craftsman, and they accepted retirement in the true spirit of the word. They retired. But it seems that retirement was not the heaven they had anticipated, and boredom, lack of incentive, and lack of activity drove them to early graves. Because of this situation, there have been many attempts to prepare people for retirement. Most of these efforts were disorganized and stressed some single phase of interest, however, the last few years have seen more planned programs, and there are some national organs which aid in readying people for retirement.

So in February a year ago, my company organized its first seminar for retirees to be, and I was one of the charter members. Ideally, this course should be taken roughly 5 years before retirement so one can prepare for that eventual

day. This being the first class of this kind at this company, there were many besides me who were on the verge of being 65 or already past it. It is a 8-9 week affair meeting once every week covering various aspects of the life that was coming. There was an invited specialists each week, a doctor to discuss health problems, a lawyer for legal problems, a representative from social security, etc.

So now I should be all prepared to enjoy the next or rather the last years of my life. I have all the theory, but like any other area, theory is not much good unless there is some practical application to back it up. So I have spent the last five months trying to reconcile all the knowledge I acquired at the seminars with the practical side.

Some guys have the knack of adapting to new situations so easily you would think they had trained for it. Others like yours truly take a while to fit in with the new conditions. This is where it seems the engineers back in Honolulu have a big advantage. There is a substantial cadre of retirees already operating which can advise and even lead the new retiree by hand as he adjusts to his new found life. That is something I do not have, and besides, I do not golf, bowl, or fish. Traveling is OK, however, always being on the road takes a lot out of me. So allow 2 - 3 months out of year for travel. That still leaves 9-10 months more to account for.

What I really lack, I told myself after several weeks of self inquiry, is something of a long term nature which will keep me interested and occupied for a long period. One thought that occurred was to start writing a book about my experiences in the war. Not for print, but just for the heck of trying to remember many of the events that took place 3-40 years ago and which become more interesting every time I recall them. The big problem is that I made no notes, no diary. I cuss the damn military brass which took away my diary just before we boarded the Lurline in April 1944. They said they would return the diaries to us, but I guess they just chucked them away or burned them. They could have been honest about it and said no diaries allowed. In any event, many of my memories border on the thin margin between fact and fiction. So there ended the prospective accounts of the GI exploits of myself.


The weather warmed up almost to spring-like temperature a few weeks, and I got out in the yard to clean up some of the mess that winter had left behind. While clearing up one area, I came across a stunted maple plant only a few inches high. At

No matter what it was, it was stunted, and there appeared a suggestion to my dilemma. I shall take up the ancient and revered Japanese art of bonsai culture. I know I am not going to be an artistic success, but the challenge was there to grow these miniatures which survive for up to hundreds of years. I don't think I will be around that long, and if I should, I don't think I will be able to afford it. At the same time, social security needs a break.

And so I have been reading what literature I can get hold of with the hope that I can grow these plants. At the same time, what available paraphernalia is being collected, and I will soon be roaming the woods in search of possible candidated for my collection. It would be nice if I could say that I have some specimens for people to see, however, this project still is in the blueprint stage. You may wonder why even mention something one has not yet started. The obvious answer is I have to get this account to Hichi before this year's NVR.





SUBJECT: 30 Percent Disabled Veterans: A Quick and Simple Way

to Fill Positions

There is a quick and easy method to fill positions using the special hiring authority for disabled veterans who have compensable service-connected disabilities of 30 percent or more. When an agency finds a veteran who has left active service with a disability of 30 percent or more or has been rated by the Veterans Administration with such a disability, the agency can hire the veteran under a temporary appointment of more than 60 days and then convert the veteran to career or career-conditional appointment at any time.

This special authority for disabled veterans is greatly underused, as data from 1981 shows that during the first half of the year, only 163 appointments under the special authority were made worldwide. Nearly all of the 163 appointments were made in the Department of the Army and the Veterans Administration. Other Defense and civilian agencies made almost no use of the authority.

Information on appointment of 30 percent disabled veterans is contained in FPM Chapter 315, Subchapter 7-8 and in FPM Letter No. 300-27. Agencies are encouraged to familiarize themselves with this appointing authority as it can be a prime way to meet goals for the employment of veterans. When OPM assumes full responsibility for affirmative action for disabled veterans in 1983, Federal agencies will be asked to establish annual affirmative action plans and to report accomplishments for reporting to Congress. Agencies are, therefore, being encouraged to start planning now by establishing routine procedures for the consideration and hiring of disabled veterans through the special authority.

These employment specialists are available to provide a full range of employment services to eligible veterans who visit the Veterans Administration Regional Office as well as the Veterans Center. Their duties include providing job applications and labor market information, including selection and referral to job openings. They will make every reasonable effort to place rehabilitated veterans and other "job ready" veterans who visit the Veterans Administration in positions consistent with their respective vocational training and skills. They will assist veterans in locating employment in the private sector and federal employment.

Priority will be given to disabled veterans, however there are no restrictions on veterans without disabilities regarding the same service. Employers wishing to hire veterans may call the following places:

Veterans are encouraged to visit the employment representative located within the Veterans Administration or at the Veterans Center.
